# TRAFFIC CODE

## 15.01 TRAFFIC REGULATIONS.

**(1) State Traffic Forfeiture Laws Adopted.** Except as otherwise specifically provided in this section, all provisions of Chapter 340 to 350 of the Wisconsin Statutes describing and defining regulations with respect to vehicles and traffic for which the penalty is a forfeiture or forfeiture and assessment of demerit points only, including penalties to be imposed and procedure for prosecution, are hereby adopted and by reference made a part of this section as if fully set forth herein, including any amendments thereto that may be subsequently adopted into law. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this section.

Sections of Chapter 340 to 350 of the Wisconsin Statutes, adopted by reference and made a part of this ordinance shall include, but not be limited to, the following:

(2) **Administrative Code Provisions.** Wis. Admin. Code Chapter TRANS 305 is hereby adopted and incorporated by reference as if fully set forth herein.

(3) **Disorderly Conduct with a Motor Vehicle.**

(a) **PROHIBITED.** No person shall cause or provoke a disturbance within the City by use of any motor vehicle, including, but not limited to, an automobile, truck, motorcycle, minibike, or snowmobile.

(b) **DEFINITION.** Disorderly conduct with a motor vehicle means engaging in violent, abusive, unreasonably loud, or otherwise disorderly conduct, including, but not limited to:

(1) Unnecessary, deliberate, or intentional spinning of wheels or squealing of tires.

- (2) “Spinning donuts” wherein a vehicle is driven rapidly in a tight radius.
- (3) “Fish-tailing” wherein the vehicle is driven in such a manner as to cause the rear end of the vehicle to unnecessarily sway from side to side.
- (4) Excessive and unnecessary acceleration.
- (5) Excessive and unnecessary revving of engine, blowing the horn, or causing the engine to backfire.
- (6) Excessive and unnecessary playing of a radio or other electric sound amplification device emitting sound from the vehicle that is audible under normal conditions from a distance of 75 or more feet, unless the electric sound amplification device is being used to request assistance or warn against an unsafe condition.
- (7) Causing a vehicle, while commencing to move to in motion, to raise one or more wheels off the ground.”

(4) **Bicycles on Sidewalks.** Pursuant to Wis. Stats. §349.94(1), bicycles may be operated on all sidewalks in the City of Middleton except where adjacent buildings are five (5) feet or less from the nearest edge of the sidewalk. At all times, consistent with Wis. Stats. §346.804, operators of bicycles on sidewalks shall yield the right-of-way to any pedestrian and shall exercise due care and give an audible signal when passing any other bicycle, electric personal assistive mobility device rider, wheelchair rider or pedestrian proceeding in the same direction.

## 15.02 SPEED LIMITS AND LOCAL RESTRICTIONS.

#### **15.04 PARKING RESTRICTIONS.**

(c) **Permit Exception.** Whenever the public interest is served thereby, permits may be issued to officers, staff or employees of the Middleton/Cross Plains School District to park contrary to the restrictions in subsection (a). Any such permits shall be issued pursuant to a cooperative agreement entered into between the City and School District under Wis. Stat. § 66.0301.

(4) **Time Restricted Parking.** No vehicle shall be parked or left standing for more than the posted time limits on the following streets or parts of streets, and signs indicating such restriction shall be erected in each restricted area on said streets:

(a) **30 Minute Parking:**

(i) Donna Drive, south side, from a point 280' east of Parmenter Street to a point 390' east of Parmenter Street.

(b) **30 Minute Parking, 8:00 AM to 6:00 PM, Monday through Friday, except Holidays:**

(i) Hubbard Avenue, north side, from Middleton Street to a point 230' west.

(c) **Two Hour Parking, 8:00 AM to 6:00 PM, daily except Sundays and Holidays:**

(i) Aurora Street from Hubbard Avenue to University Avenue

(ii) Parmenter Street from Terrace Avenue to University Avenue

(iii) Hubbard Avenue from Aurora Street to Middleton Street

(iv) Elmwood Avenue from a point 550' east of Parmenter Street west to Cayuga Street

(v) Mayflower Drive from University Avenue to Elmwood Avenue

(vi) Elmwood Avenue, south side, from a point 300 feet east of North High Point Road west to North High Point Road.

(d) **Two Hour Parking, 7:30 AM to 4:30 PM, School Days;**

(i) Lee Street, both sides, from Parmenter Street to Clark Street

(ii) Parmenter Street, east side, from University Avenue to the Parmenter Street roundabout except for those areas designated as "no parking" under

subsection (2)

(iii) Franklin Avenue, south side from eastern right-of-way of Parmenter Street extending east to western right-of-way to Clark Street

(iv) Rohlich Court, both sides, from western-right-of-way line of Parmenter Street extending 140' west

(v) Ravine Drive, both sides, from Donna Drive to Nightingale Lane

(5) **Seasonal Night Parking 1:00 AM to 7:00 AM.**

(a) No vehicle shall be parked or left standing between the hours of 1:00 AM and 7:00 AM on the even numbered side of any street on odd numbered calendar days and on the odd numbered side of any street on even numbered calendar days between November 15 and March 15 in each year, except on the streets and highways listed in (c). These parking restrictions shall be in addition to and shall supersede all other parking regulations from time to time existing on any street or highway in the City.

(b) Notice. Signs giving notice that night parking restrictions are in effect in the City of Middleton shall be placed or erected at or near the corporate limits of the City on all state and country trunk highways and connecting streets. Such signs shall be reflectorized and of a type approved by the State Highway Commission as to size of lettering, shape and coloring in accordance with Wis. Stat. s. 349.13.

(c) Exceptions. The following streets shall be excepted from the provisions of this subsection:

1. Blocks of streets which prohibit parking at all times on one side of said block or street and which permit parking of any status on the other side of said block or street. "Block" shall mean that portion of a street between two intersecting streets. For purposes of this section, an intersecting street includes both a street which fully intersects the street in question, and a street which begins or terminates at the street in question.

2. Parmenter Street from University Avenue to South Avenue  
Middleton Beach Road  
Middleton Street south of Voss Parkway"

(6) **Miscellaneous Restrictions.**

(a) Storage of Vehicles, Boats, Trailers Prohibited. No person shall leave a vehicle, boat, or trailer standing upon any street, highway, municipal parking lot in the City for storage purposes. Storage is defined as the leaving of a vehicle, boat, or trailer standing on a street, highway or municipal parking lot for a continuous period of twenty four (24) hours or more.

(b) Unattended Vehicle with Motor Running. No motor vehicle shall be left standing upon any street in the City with the motor running except when attended by a licensed operator.

**(c) Removal of illegally parked vehicles.** Whenever the Chief of Police, any police officer or traffic officer finds a vehicle standing upon a street, highway, public or private property in violation of a prohibition, limitation or restriction on stopping, standing or parking, he or she is authorized to move such vehicle or to require the operator in charge thereof to move such vehicle to a position where such stopping, standing, or parking is not prohibited. Such removal shall not relieve the owner of such vehicle from any penalty because of such violation. Any vehicle parked or left standing in violation of any parking restriction may be towed to a public garage, or other legal parking area, and the cost of towing and storage, if any, shall be assessed against the owner as costs, in addition to the penalty provided for the ordinance violation.

**(d) Temporary No Parking Zones.**

**(i) Authority to Designate Temporary No Parking Zones.** The Chief of Police may designate temporary no parking zones upon finding that the public safety, the orderly flow of vehicular or pedestrian traffic, street maintenance, snow removal, or other proper purposes requires such action. When such designation is made by filing notice with the City Clerk's office, the Director of Public Works shall cause appropriate temporary signs to be erected and shall remove said signs when they are no longer needed.

**(ii) Permits for Temporary No Parking Zone.** Any church, school, organization, business or government entity may apply to the Chief of Police for permission to temporarily prohibit parking on any street fronting the property of such applicant. Applications for this purpose shall be made on a form designated by the Chief of Police and shall include a description of the purpose for which the permit is sought, the number of hours and the street location sought to be restricted. The application may cover either an individual event or a reoccurring purpose. No permit may be granted unless the applicant agrees to furnish official traffic signs conforming to the State Uniform Control Devices Manual prior to the effective date and time of the permit's first use. No sign shall be placed or remain more than 30 minutes prior to or after the event for which the permit was granted.

**(f) Private Parking Restrictions.** No person shall, without the permission of the owner or lessee of any public or private property, leave or park any vehicle thereon contrary to a posted sign thereon, if there is in plain view on such property a "No Parking" sign, or a sign indicating limited or restricted parking. Owners or lessees of such property may prohibit parking by certain persons and prohibit it or limit it as to other persons.

**(h) Vehicle Abandonment Prohibited; Removal; Disposal Violation.**

**(i) No person shall leave unattended any motor vehicle, trailer, semi-trailer, or mobile home on any public street or highway or private or public property in the City for such time and under such circumstances as to cause the vehicle to reasonably appear to have been abandoned. Except as otherwise provided in this subsection, whenever any vehicle has been left unattended on any street or highway in the City or upon private or public property without the permission of the property owner or other person charged with the lawful jurisdiction thereof for more than forty eight (48) hours, the vehicle is**

deemed abandoned and constitutes a public nuisance. A motor vehicle shall not be considered an abandoned motor vehicle when it is out of ordinary public view, or when designated as not abandoned by the Police Chief or his or her designee.

(ii) **Removal and Impoundment of Vehicles.** Any vehicle in violation of subdivision (i) shall be removed and impounded until lawfully claimed or disposed of under the provisions of subdivision (iii) except that if it is deemed by the Police Chief or his or her designee that the cost of towing and storage charged for the impoundment would exceed the value of the vehicle, the vehicle may be junked or sold prior to expiration of the impoundment period upon determination by the Police Chief or his or her designee that the vehicle is not stolen or otherwise wanted for evidence or other reason. All substantially complete vehicles in excess of nineteen model years of age shall be disposed of in accordance with subdivision (iii).

(iii) **Removal, Storage, Notice, Reclaim, or Disposal of Abandoned Vehicles.** The provisions of this subdivision shall apply to the removal, storage, notice, reclaim or disposal of abandoned vehicles.

**REMOVAL:** Any police officer who discovers any motor vehicle, trailer, semi trailer or mobile home on any public street or highway or private or public property in the City which has been abandoned shall cause the vehicle to be removed to a suitable place of impoundment. Upon removal of the vehicle the police officer shall notify the Police Chief or her or his designee of the abandonment and of the location of the impounded vehicle.

**STORAGE AND RECLAIM:** Any vehicle which is deemed abandoned by the Police Chief or designee and not disposed of under subdivision (ii) shall be retained in storage for a minimum period of ten (10) days after certified mail notice, as hereinafter provided, has been sent to the owner and lienholders of record to permit reclamation of the vehicle after payment of accrued charges. Any abandoned vehicle may be lawfully reclaimed, may be released upon the payment of all accrued charges, including towing, storage and notice charges and upon presentation of the vehicle title or other satisfactory evidence to the Police Chief or designee to prove an ownership or lienholder interest in said vehicle.

**NOTICE TO OWNER OR LIENHOLDERS OF RECORD:** Pursuant to Wis. Stat. s. 342.40(3), certified mail notice, as referred to herein, shall notify the owner of the abandoned vehicle, if any, and or the lienholders of record, if any, of the year, make, model and serial number of the abandoned vehicle and the place where the vehicle is being held and shall inform the owner or lienholders to exercise their rights to reclaim the vehicle under this section. The notice shall state that the failure of the owner or lienholders to exercise their rights to reclaim the vehicle under this section shall be deemed a waiver of all right, title, and interest in the vehicle and a consent to the sale of the vehicle and that the vehicle has been deemed abandoned and impounded by the City and if the "determined value" of the abandoned vehicle or the cost of towing and storage charges will exceed the determined value of the vehicle; that if the vehicle is not wanted for evidence or for any other reason, the vehicle may be reclaimed upon the payment of all accrued charges, including towing, storage and notice charges, within ten days of the date of mailing the

notice, unless the Police Chief or designee has determined that the cost of towing and storage charges for impoundment will exceed the value of the vehicle. Within ten days from the date of mailing the notice and upon the payment of the aforesaid charges the owner or aforesaid

lienholders or record may, upon request made within the ten day period, be granted a hearing relative to the determinations made with respect to the value of said vehicle. Said hearing shall be before the Chief of Police.

**DISPOSAL OF ABANDONED VEHICLES.** Any abandoned vehicle impounded by the City which has not been reclaimed or junked or sold by direct sale to a licensed salvage dealer pursuant to the provisions hereof, may be sold by public auction sale or public sale, pursuant to Wis. Stat. s. 342.40(c), Class 1 Notice, including the description of the vehicle, the name(s) and address(es) of the owners and lienholders of record, if known, as well as the information contained in the notice sent to the owners and lienholders of record, and the time of the sale, shall be published before the sale, at which sale the highest bid for any such motor vehicle shall be accepted unless it is deemed inadequate by the Police Chief or designee. The Police Chief or designee may readvertise the sale, adjourn the sale to a definite date, sell the motor vehicle at a private sale or junk the vehicle. Any interested person may offer bids on each abandoned vehicle to be sold. The purchaser shall have ten days to remove the vehicle from the storage area, but shall pay a storage fee for each day the vehicle remains in storage after the second business day subsequent to the sale date. Ten days after the sale, the purchaser shall forfeit all interest in the vehicle and the vehicle shall be deemed abandoned and may be sold again.

**REPORT OF SALE OR DISPOSAL:** Within five days after the direct sale or disposal of a vehicle as provided in this subsection or subsection (b), the Chief or designee shall advise the State Of Wisconsin Department of Motor Vehicles, of such sale or disposal on a form supplied by the Division. A copy of the form shall be given to the purchaser of the vehicle.

**OWNER RESPONSIBLE FOR IMPOUNDMENT AND DISPOSAL COSTS:** The owner of any abandoned vehicle, except a stolen vehicle, is responsible for the abandonment and all costs of impounding and disposing of the vehicle. Costs not recovered from the sale of the vehicle may be recovered in a civil action by the City against the owner.

(i) **Truck Routes.** No vehicles, with a gross weight of 10,000 pounds or more, may be parked, stopped, or left standing other than on streets designated in or under the exceptions of section 15.06 of this Code.

(j) **Unregistered Motor Vehicle Prohibited:** No person shall leave attended or unattended any motor vehicle, trailer, semi-trailer, or mobile home on a public street or highway, not currently registered and under such circumstances as to cause such vehicle to reasonably appear to have been unregistered for not less than 30 days. Except as otherwise provided in this subsection whenever any vehicle has been found unregistered it may be cited for this violation, towed and impounded. Any vehicle shall not be considered unregistered when it is out of ordinary public view, or when designated as not unregistered by the Wisconsin Department of Transportation.

**(k) No person shall park any vehicle on public or private property in any place not clearly designated as a parking spot so as to prevent any person from freely moving his or her vehicle from a lawfully parked position unless express or implied permission is given by the owner or operator of said vehicle.**

(9) **No Parking at Any Time.** No vehicle shall be parked, stopped or left standing at any time on streets at locations adjacent to curb returns (the curved section of curb connecting the curbs of intersecting streets) of street intersections beginning at the point of curvature (the point at which the curve begins) and ending at the point of tangency (the point at which the curve ends) of the curb return.

(10) **Parking in Municipal Parking Lots.**

(a) **Two Hour Parking.** No vehicle shall be parked or left standing for more than two (2) hours between the hours of 8:00 a.m. and 6:00 p.m. daily, except Sundays and holidays, in the municipal parking lots having street addresses of 7429 and 7437 Hubbard Avenue.

(b) **Four Hour Parking.** No vehicle shall be parked or left standing for more than four (4) hours between the hours of 8:00 a.m. and 6:00 p.m. daily, except Sundays and holidays, in the municipal parking lot having a street address of 7438 Hubbard Avenue. Four hour parking restrictions shall not apply to any handicap parking stall officially marked pursuant to Wis. Stats. §346.505. Residents of any apartment in a building on the same block or across the street from the block upon which this lot sits may obtain a residential parking permit pursuant to subsection (12) to exempt one vehicle from the restrictions of this subsection if the apartment property in which they reside has no parking facility available to it.

(c) **Special Event Exception.** Whenever the Chief of Police determines that a special event will occur that requires additional enforcement for violations of any time limit in the municipal parking lots, the Chief shall direct the placement of temporary signs in each such municipal parking lot identifying the special event restrictions and designating such areas as vehicle tow-away zones subject to removal pursuant to Section 15.04(6)(e).

(11) **Loading Zones.** No person shall stop or leave any vehicle standing in any of the following places except temporarily for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers, and signs indicating such restriction shall be erected in each restricted area on said streets, as follows:

(a) **15 Minute Loading Zone, Weekdays, 3:00 p.m. to 6:00 p.m.:**

Terrace Avenue, south side, from an extension of the easterly property line of 7737 Terrace Avenue to a point 105' westerly

**(b) 15 Minute Loading Zone, 9:00 a.m. to 9:00 p.m.:**

Parmenter St, west side, beginning from a point 53' south of the centerline of Franklin Ave, extending 50' southerly

**(12) Residential Parking Permits.**

(a) Except as provided below, pursuant to Wis. Stats. §§ 349.13(1e)(a) and (1g), any person who is the head of a household of the City of Middleton whose residence abuts a street on which parking is restricted pursuant to Section 15.04(3)(a) of this Code may obtain a permit to park a vehicle upon that street without regard to those restrictions. Up to four permits may be issued to the head of household for each residence abutting a street on which parking is restricted pursuant to Section 15.04(3)(a) of this Code. The City Clerk may grant additional permits upon good cause shown by the applicant. Permits may also be transferred to vehicles of guests of permit holders. Persons residing on corner lots may only be issues permits effective on the street corresponding to their street address. Such permit shall not be construed as authorizing to park contrary to any parking restrictions in effect pursuant to any other authority.

(b) Procedure. To obtain a residential parking permit pursuant to this section, an application shall be made, under oath, to the City Clerk's Office for such permit on a form approved by the City Clerk. Such form shall include, in addition to any other information required by the City Clerk, the name and permanent address of the individual applying for the permit and the license plate number of each vehicle registered to the resident's address.

(c) Issuance.

(1) The City Clerk, or his or her designee, shall verify from the information provided in the application that the applicant is a resident at the address provided. Residency shall be determined in accordance with Wis. Stats. § 6.10(1). The City Clerk, or his or her designee, may require the applicant to submit any additional information necessary to make this determination.

(2) The form of the permit shall be established by the City Clerk. The manner in which the permit shall be displayed shall appear on the face of the permit. Once issued, the permit shall be clearly displayed as directed. Permits shall not be considered valid unless they are properly displayed.

(d) Non-issuance and invalidation. No permit shall be issued, or be considered valid where it is displayed upon a vehicle which is not properly registered and in full compliance with all statutes, rules and regulations necessary for the vehicle to be operated upon a public highway.

(e) Exceptions. No permit under this section shall authorize parking contrary to posted restrictions on the following sections of streets:

Branch Street, east side, adjacent to Sauk Trail School Property.  
Bristol Street, east side, from Franklin Avenue to Maywood Avenue.  
Bristol Street, west side, from Franklin Avenue to Maywood Avenue.  
Donna Drive, south side, adjacent to Kromrey School property.  
Franklin Avenue, north side, from Middleton Street to Bristol Street.  
Middleton Street, east side, from North Avenue to Franklin Avenue.  
North Avenue, north side, from the easterly property line of Fireman's Park to Middleton Street.  
Park Street, west side, from the centerline of Donna Drive to a point 585' south of the centerline of Donna Drive.  
Woodgate Road, south side, adjacent to Elm Lawn School property.

(13) Repealed 12/1/15

(14) **Angle Parking.** Pursuant to the authority granted by Wis. Stats. §349.13(2)(e), this ordinance is created in furtherance of the goals of public convenience, general welfare and prosperity, to increase the amount of available parking in the downtown area which the Common Council finds necessary to facilitate business activities in conjunction with the City's downtown redevelopment and revitalization efforts.

(a) Angle parking is hereby permitted in designated angle parking stalls on both sides of Elmwood Avenue between North High Point Road and Cayuga Boulevard providing that such parking is created in accordance with plans and specifications approved by the Director of Public Works.

(b) Angle parking is hereby permitted in designated angle parking stalls on one side of Hubbard Avenue between Parmenter Street and Aurora Street.

(c) **Permit Parking.** The City Council may designate certain angle parking stalls to allow parking by permit only from 7:00 a.m. to 6:00 p.m. The number of stalls so designated on each street with angle parking shall be less than or equal to the number of additional stalls created on that street as a result of the implementation of angle parking as certified by the Direction of Public Works. If any angle parking stalls are designated as permit-only stalls during specified hours, said designation shall not take effect until official signs have been erected in front of each designated stall indicating that parking shall be by permit only and the times such regulation is in effect. No other parking restrictions shall be effective for parking stalls designated for permit parking under this section during the time specified herein. Permits shall be issued by the City Clerk. Permittees shall affix the permit to the rearview mirror on the vehicle or as otherwise directed by the permit.

#### **15.07 SCHOOL BUS WARNING LIGHTS.**

**Whenever a duly licensed school bus is equipped with flashing red warning lights, such lights shall be used by a bus operator within a residence or business district in the City when pupils or other authorized passengers are to be loaded or unloaded at a location at which there are no traffic signals and such persons must cross the street or highway before being loaded or after being unloaded, except when adjacent to school property.**

#### **15.08 OFFICIAL SCHOOL CROSSINGS.**

**The penalty for violations of any provision of this Chapter shall be a forfeiture as provided in Wis. Stat. s. 345.26(2)(a) and s. 30.04 of this Code. A schedule of deposits for violation of this Chapter is set forth in Chapter 2 of this Code.**

**15.19 NEIGHBORHOOD ELECTRIC VEHICLES.**

- (1) Neighborhood Electric Vehicles Permitted. Pursuant to Wis. Stats. § 349.26, the Common Council hereby authorizes the operation of neighborhood electric vehicles meeting the requirements of subsection (2) on any highway in the City of Middleton having a speed limit of 35 miles per hour or less. Headlamps must be on at all times during**

operation on City streets. This section is adopted pursuant to the authority set forth in Wis. Stats. § 349.26 and adopted for the protection of the public health, benefit and welfare of the City.

**(2) Equipment and Specifications.**

(a) Neighborhood electric vehicle means a self-propelled motor vehicle that has successfully completed Neighborhood Electric Vehicle America test program conducted by the federal department of energy and that conforms to the definition and requirements for low speed vehicles as adopted in the Federal Motor Vehicle Safety Standards for "low-speed vehicles" under 49 C.F.R. 571.3 and 571.500. Neighborhood electric vehicle does not include an electric golf cart unless it meets all of the requirements of this section 15.19.

(b) Neighborhood electric vehicles shall have four-wheels and have a speed range of at least 20 miles per hour and not more than 35 miles per hour on a paved surface and have a gross vehicle weight at rest of less than 2,500 pounds.

(c) Neighborhood electric vehicles shall be equipped with the following:

1. Headlamps.
2. Front and rear turn signals.
3. Stop lamps.
4. Three reflex reflectors consisting of one red reflector on each side as far to the rear as practicable and one red reflector on the rear.
5. An exterior mirror mounted on the driver's side and either an exterior mirror on the passenger side or an interior rearview mirror.
6. Parking brakes.
7. A windshield that conforms to the requirements of the federal motor vehicle safety standard on glazing materials under 49 C.F.R. 571.205.
8. A vehicle identification number (VIN) that complies with 49 C.F.R. 565.
9. A Type 1 or Type 2 seatbelt assembly conforming to 49 C.F.R. 571.209 and Federal Motor Safety Standard No. 209, for each designated seating position.

**(3) Registration.** Neighborhood electric vehicles shall be registered and display such registration in conformity with Wis. Stats. Chap. 341.

**(4) Enforcement.** Any person who violates any provision of this section shall be subject to forfeiture as provided in Section 15.25.

**(5) Exceptions.** Notwithstanding subsection (1), neighborhood electric vehicles shall not be permitted to travel on the following highways or portions of highways:

(a) University Avenue, from the intersection with Cayuga Street west to the beginning of U.S. Highway 14.

(b) U.S. Highway 14 or upon any at-grade crossing of U.S. Highway 14 except at-grade

**crossings shall be permitted at Deming Way.**

**(c) U.S. Highway 12 or upon any at-grade crossing of U.S. Highway 12.**

**(6) Severability. If any portion of this ordinance, or its application to any person or circumstances, is held invalid, the validity of this section as a whole, or any other provision herein and its application to other persons or circumstances, shall not be affected.**

#### **15.25 ENFORCEMENT PROVISIONS.**

**This Chapter shall be enforced in accordance with the provisions of Wis. Stat. sections 345.20 through 345.53, Chapter 800 and s. 66.12 of the Wisconsin Statutes.**

**(1) Parking Citations. Citations for all nonmoving traffic violations under this Chapter shall conform to Wis. Stat. s. 345.28, and shall permit direct mail payment of the applicable forfeiture to the police department.**

**(2) Collection of Unpaid Moving Traffic Citations.**

**(a) For purposes of this Chapter, the "legal authority" designated by Wis. Stat. s. 345.28(4) is the Chief of Police or her or his designee.**

**(b) Whenever the Chief notifies the State Department of Transportation of non-payment and non-appearance in response to a citation for a nonmoving traffic violation, the Chief shall specify that the Department is both to suspend the registration of the vehicle involved under Wis. Stat. s. 341.63(1)(c) and also to refuse registration of any vehicle owned by the person under Wis. Stat. s. 341.10(7m).**

**(c) The costs of participating in the State Traffic Violation and Registration Program shall be assessed to the person involved. Such costs include the prepayment required by the Department of Transportation under Wis. Stat. s. 85.13, as well as a \$15.00 fee for the City's administrative costs in preparing the notices required by Wis. Stat. s. 345.28(3).**
